## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN A LIDELL JR AND VAUNIECE J LIDELL RT 1 BOX 255 TERREBONNE OR 97760

confirms the right to use the waters of WELL 12, within the DESCHUTES RIVER BASIN, for IRRIGATION of 3.8 ACRES.

This right was perfected under Permit G-4396. The date of priority is APRIL 15, 1969. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.05 cubic foot per second, if available at the original wells, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

14 S	12 E	WM	21	NW NE	514 FEET SOUTH & 2423 FEET WEST FROM NE CORNER, SECTION 21

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

This use may be regulated if analysis of data available discloses that the appropriation will measurably reduce the surface water flow necessary to maintain the free-flowing character of a scenic waterway in quantities necessary for recreation, fish and wildlife in effect as of the priority date of this right or as those quantities may be reduced.

## NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When in the judgment of the Watermastser it becomes necessary to install measuring devices:

the pump system shall include an in-line flow meter or other suitable device for measuring the water to which the water user is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of the Watermaster.

The quantity of water diverted at the new point of appropriation (well), together with that diverted at the old points of appropriation, shall not exceed the quantity of water available from the original points of appropriation described as follows:

When required by the Department the water user shall install in-line flow meters or other suitable devices for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface source as the original point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm changes in PLACES OF USE AND POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered November 25, 1998, at Special Order Volume 52, Page 1040, approving Transfer Application 6836, and together with Certificate 75894, supersedes Certificate 67899, State record of Water Right Certificates.
