 CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of EAST FORK ILLINOIS RIVER, tributary to ILLINOIS RIVER for IRRIGATION OF 19.2 ACRES AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Josephine County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 13, at Page 70. The date of priority is MAY, 1887.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed for said purposes, and shall not exceed one cubic foot per second for each 50 acres of land irrigated during the irrigation year from April 1 to November 1 of each year (0.38 CUBIC FOOT PER SECOND), or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

A description of the place of use is as follows:

Water shall be acquired from the same surface source as the original point of diversion.

The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original point of diversion described as follows:

38 S	8 W	WM	27	SE NW	KIRBY DITCH - 1600 FEET SOUTH & 1800 FEET EAST FROM NW CORNER

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water user shall maintain a fish screen or fish by-pass device.


NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered September 4, 1997, at Special Order Volume 51, Page 1054, approving Transfer Application 7775, and together with Certificate 75116, supersedes Certificate 13878, State Record of Water Right Certificates.
