CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DR. DONALD W. SPROAT 1205 NE WYOMING DRIVE PRINEVILLE OR 97754

confirms the right to use the waters of OCHOCO CREEK, tributary to CROOKED RIVER for IRRIGATION of 8.1 ACRES.

This right was perfected under Permit 52 and confirmed by decree of the Circuit Court of the State of Oregon for CROOK County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449. The date of priority is JULY 8, 1909.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.10 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:
