This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1867.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.043 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.
