confirms the right to use the waters of THREE WELLS in BEAVER CREEK BASIN for SUPPLEMENTAL IRRIGATION of 2.4 ACRES.

This right was perfected under Permit G-10629. The date of priority is JUNE 18, 1986. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.019 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre and is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The water user shall maintain in-line flow meters or other suitable devices for measuring and recording the quantity of water used.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
