## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of PARKER CREEK, tributary to ROUGH AND READY CREEK for DOMESTIC USE INCLUDING IRRIGATION NOT TO EXCEED ¼ ACRE OF NON-COMMERCIAL LAWN AND GARDEN FOR EACH FAMILY DURING THE IRRIGATION SEASON OF EACH YEAR, FROM APRIL 1 TO NOVEMBER 1.

This right was perfected under Permit S-13080. The date of priority is JUNE 21, 1938. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.03 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

Water shall be acquired from the same surface source as the original point of diversion.

The water user shall maintain a fish screen or fish by-pass device.

This certificate is issued to confirm a CHANGE IN POINT OF DIVERSION, PLACE OF USE, AND CHARACTER OF USE approved by an order of the Water Resources Director entered JANUARY 14, 2002, at Special Order Volume 56, Page 45, approving Transfer Application 8274, and together with Certificate 79174, supersedes Certificate 76872, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
