# CERTIFICATE OF WATER RIGHT

# THIS CERTIFICATE ISSUED TO

# CHUCK AND BILL BRUCE 2800 GARDNER RD EAGLE POINT OR 97524

confirms the right to use the waters of MAPLE CREEK AND 150.0 ACRE-FEET SUPPLEMENTAL STORAGE IN WADE RESERVIOR UNDER THE PROVISIONS OF PERMID R-2706, a tributary of LITTLE BUTTE CREEK, for SUPPLEMENTAL IRRIGATION OF 5.0 ACRES.

This right was perfected under Permit 27726. The date of priority is NOVEMBER 21, 1961. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.06 CUBIC FOOT PER SECOND AND 150.0 ACRE FEET, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-2706. The amount allowed herein, together with the amount secured under any other right existing for said lands, shall be limited by the duty of water as fixed herein; provided further that the right to use the direct flow shall be limited to the period when the flow of the Rogue River is more than 1000 cubic feet per second (cfs) at Raygold, more than 1000 cfs immediately above Savage Rapids Dam and more that 735 cfs at its mouth.

A description of the place of use is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
