CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WAYNE MITCHELL 67165 HARRINGTON LOOP BEND, OR 97701

confirms the right to use the waters of the A WELL, a tributary to the DESCHUTES BASIN for IRRIGATION of 10.06 ACRES.

This right was perfected under Permit G-10670. The date of priority is SEPTEMBER 25, 1986. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.13 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water wells in Oregon.

This certificate describes that portion of the water right confirmed by Certificate 86336 not transferred by an order of the Water Resources Director entered 22 2013, at Special Order Volume Approving Transfer Application T-11132. This certificate also corrects a scrivener's error in the character of use in previous Certificates 81614 and 86336. This Certificate supersedes Certificate 86336, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
