confirms the right to use the waters of WHYCHUS CREEK, a tributary to the DESCHUTES RIVER for IRRIGATION of 61.15 ACRES AND DOMESTIC USE, (IRRIGATION DURING THE IRRIGATION SEASON).

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 120, Volume 1, at Page 120. The date of priority is SEPTEMBER, 1902.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.23 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.
