confirms the right to use the waters of THREE WELLS, within the COLUMBIA RIVER BASIN for IRRIGATION of 6.4 ACRES.

This right was perfected under Permit G-4918. The date of priority is FEBRUARY 3, 1970.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.023 CUBIC FOOT PER SECOND (CFS), BEING 0.005 CFS FROM WELL 62, 0.012 CFS FROM WELL 62A, AND 0.006 CFS FROM WELL 62B, or its equivalent in case of rotation, measured at the wells.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
