CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BONANZA VIEW DAIRY PARTNERSHIP
4721 HARPOLD RD
BONANZA OR 97623

confirms the right to use the waters of TWO WELLS, within the LOST RIVER BASIN for IRRIGATION of 10.0 ACRES.

This right was perfected under Permit G-9436. The date of priority is AUGUST 27, 1981.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.125 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

39 S	11 E	WM	21	SE NE	WELL 1 - 2300 FEET SOUTH AND 140 FEET WEST FROM NE CORNER, SECTION 21
39 S	11 E	WM	22	NW NW	WELL 2 - 450 FEET SOUTH AND 800 FEET EAST FROM NW CORNER, SECTION 22

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. In the event of a request for a change in point of appropriation, an additional point of appropriation, or repair of the wells, the quantity of water allowed herein together with any other right from these points of appropriation shall not exceed the capacity of these wells at the time of perfection of this right.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a CHANGE IN PLACE OF USE approved by an order of the Water Resources Director entered DECEMBER 2, 2002, at Special Order Volume 56, Page 2146, approving Transfer Application 9100, and together with Certificate 79698, supercedes Certificate 65493, State record of Water Right Certificates.


NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
