CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD L. OFFENBACHER

confirms the right to use the waters of Applegate River and 4.0 acre-feet stored water from Applegate Lake Reservoir (constructed under Permit R-7810), tributaries of the Rogue River for the purpose of irrigation of 1.5 acres and supplemental irrigation of 0.7 acre.

The right was perfected under Permit S-46087 and the right to the use of said waters has been perfected in accordance with the laws of Oregon. The priority date of the right is August 14, 1981.

The amount of water to which such right is entitled to the purposes aforesaid, is limited to an amount actually beneficially used for said purposes and shall not exceed 0.02 cubic foot per second and stored water only on lands described as supplemental, or its equivalent in case of rotation, measured at the point of diversion from the stream. The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage, and is subject to the terms and conditions of Contract 1-07-10-W0397 between the Bureau of Reclamation and the applicant, or a satisfactory replacement.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed and to which such right is appurtenant is as follows:



This certificate describes that portion of the water right confirmed by Certificate 56004, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered July 24, 2013, and recorded in Special Order Volume 89, Pages 1046-1047 canceling a portion of the water right. This certificate supersedes Certificate 56004.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
