### CERTIFICATE OF WATER RIGHT

### THIS CERTIFICATE ISSUED TO

ROGUE COMMUNITY COLLEGE c/o LYNDA WARREN 3345 REDWOOD HWY GRANTS PASS OR 97527-9298

confirms the right to use the waters of THREE WELLS in SAND CREEK BASIN for PRIMARY IRRIATION OF 1.6 ACRES, SUPPLEMENTAL IRRIGATION OF 6.1 ACRES, DOMESTIC AND FIRE PROTECTION.

This right was perfected under Permit G-2977, The date of priority is JULY 15, 1965. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 50 GALLONS PER MINUTE, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The quantity of water diverted at the new points of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original points of diversion.

The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.

The water user shall monitor and report the impact of water use under this right according to the monitoring plan approved by the Department prior to issuance of a certificate or any subsequent plan that may be approved by the Department after the issuance of the confirming certificate.

The initial water level in Well 1 (Jose 4437) to which subsequent water levels will be referenced is 51.03 feet below land surface (March 10, 2010).

The initial water level in Well 2 (Jose 4438) to which subsequent water levels will be referenced is 88.71 feet below land surface (March 10, 2010).

The initial water level in Well 3 (Jose 4436) to which subsequent water levels will be referenced is 53.65 feet below land surface (April 2001).

If any well or replacement well(s) displays a total static water-level decline of 25 or more feet over any period of years, as compared to the reference level, then the water user shall discontinue use of, or reduce the rate or volume of withdrawal from the well(s). Such action shall be taken until the water level recovers to above the 25-foot decline level or until the Department determines, based on the water user's and/or the Department's data and analysis, that no action is necessary because the aquifer in question can sustain the observed declines without adversely impacting the resource or senior water waters. The water user shall in no instance allow excessive decline, as defined Commission rules, to occur within the aquifer as a result of use under this certificate.

The Director may require pump test results every ten years.

Water shall be acquired from the same aquifer as the original point of appropriation.

This certificate is issued to CONFIRM AN ADDITIONAL POINT OF APPROPRIATION, AND A CHANGE IN PLACE OF USE, AND CHARACTER OF USE, approved by an order of the Water Resources Director entered MAY 10, 2010, at Special Order Volume 80, Page 922, approving Transfer Application 10283, and supercedes Certificate 35634, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
