CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DANIEL RUPERT MADDOX 1030 FRENCH GULCH RD JACKSONVILLE OR 97530

confirms the right to use the waters of POORMAN CREEK, tributary to FOREST CREEK for IRRIGATION of 1.24 ACRES.

This right was perfected under Permit S-46507. The date of priority is MARCH 24, 1982. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.015 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original point of diversion described as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface source as the original point of diversion.

This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the Water Resources Director entered July 12, 2001, at Special Order Volume 55, Page 743, approving Transfer Application 8019, and together with Certificate 77008, supercedes Certificate 68151, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
