confirms the right to use the waters of LA SIEUR CREEK (AKA LA SERE CREEK), tributary to DREWS CREEK for IRRIGATION of 8.25 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Lake County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7, at Page 233. The date of priority is 1884.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.75 ACRE FOOT PER ACRE DURING ANY 30 DAY PERIOD PRIOR TO JUNE 1<sup>ST</sup>, and 0.5 ACRE FOOT PER ACRE DURING ANY 30 DAY PERIOD AFTER JUNE 1<sup>ST</sup> OF EACH YEAR; and 2.5 ACRE FOOT PER ACRE DURING ANY IRRIGATION SEASON; to be diverted under a head of not to exceed ONE-FORTIETH OF A SECOND FOOT PER ACRE.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a CHANGE IN PLACE OF USE approved by an order of the Water Resources Director entered DECEMBER 1, 2004, at Special Order Volume 62, Page 255, approving Transfer Application 9588, and together with Certificate 80734, supercedes Certificate 5182, State Record of Water Right Certificates.
