confirms the right to use the waters of WELL 8, within the DEEP CANYON CREEK BASIN for IRRIGATION of 28.8 ACRES.

This right was perfected under Permit G-7360. The date of priority is DECEMBER 15, 1976.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.357 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
