CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of UMATILLA RIVER, tributary to COLUMBIA RIVER for IRRIGATION of 10.9 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page 127. The date of priority is 1910.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.14 CUBIC FOOT PER SECOND, SUBJECT TO THE PROVISIONS OF PARAGRAPH 33 OF SAID DECREE, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

4 N	28 E	WM	16	SW SW	660 FEET NORTH AND 10 FEET EAST FROM SW CORNER, SECTION 16

A description of the place of use is as follows:

4 N	28 E	WM	16	SW SW	7.4

The water user shall maintain flow control devices, in-line flow meters, weirs or other suitable devices for measuring and recording the quantity of water delivered from each source to the center pivot irrigation system to insure that the proper source is being used on the proper lands. The water user shall report total flow figures when requested by the Watermaster. The Watermaster may operate the flow control devices and monitor the accuracy of the measuring device, as needed.

This certificate is issued to confirm a CHANGE IN PLACE OF USE approved by an order of the Water Resources Director entered AUGUST 7, 2003, at Special Order Volume 57, Page 1270, approving Transfer Application 8322, and together with Certificate 80397, supercedes Certificate 2554, State Record of Water Right Certificates.


**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.
