CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WALTER AND WENDY HAZEN
91528 CAPE ARAGO HWY
COOS BAY OR 97420

confirms the right to use the waters of NORTH FORK COQUILLE RIVER, tributary to COQUILLE RIVER for IRRIGATION of 16.8 ACRES.

This right was perfected under Permit S-29480. The date of priority is MARCH 30, 1964. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.21 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

27 S	12 W	WM	25	SW NW	2053 FEET SOUTH AND 872 FEET EAST FROM NW CORNER, SECTION 25

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

Twp	Rng	Mer	Sec	Q-Q	Acres
27 S	12 W	WM	25	SW NW	4.3
27 S	12 W	WM	25	SE NW	12.5

The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original point of diversion.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface source as the original point of diversion.

The water user shall maintain a fish screen or fish by-pass device.


NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a NEW POINT OF DIVERSION approved by an order of the Water Resources Director entered JULY 30, 2004, at Special Order Volume 60, Page 832, approving Transfer Application 9453, and together with Certificate 80872, supercedes Certificate 45028, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
