CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of BIG CREEK AND SEVEN UNNAMED RESERVOIRS 1, 2, 3, 4, 5, 6, and 7 CONSTRUCTED UNDER APPLICATIONS R-74440 AND R-74441, PERMITS R-13159 AND R-12960, TRIBUTARIES OF FLORAS LAKE for PRIMARY AND SUPPLEMENTAL CRANBERRY OPERATIONS on 56.9 ACRES.

This right was perfected under Permit S-53713. The date of priority is AUGUST 26, 1994. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.2 CUBIC FEET PER SECOND (CFS) OF LIVE FLOW FROM BIG CREEK TO REFILL RESERVOIRS AS NEEDED AND 89.0 ACRE-FEET (AF) PER YEAR, FROM STORED WATER, FROM RESERVOIRS DESCRIBED BELOW FOR SUPPLEMENTAL CRANBERRY OPERATIONS measured at the points of diversion.

The period of use for live flow from Big Creek is 0.79 CFS during the month of December, 0.95 CFS during the month of January, 1.20 CFS during the month of February, 1.20 CFS during the month of March, 0.73 CFS during the month of April, and 0.24 CFS during the month of May; stored water may be used year-round.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

The amount of water diverted for CRANBERRY OPERATIONS, together with amounts secured under any other rights existing for the same lands, is limited as follows: For temperature control, 0.15 cubic foot per second per acre. For flood harvesting or pest control, 0.05 cubic foot per second per acre. For irrigation of cranberries, ONE-FORTIETH of one cubic foot per second and 3.0 acre feet per acre for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop, the amount of water diverted is limited to ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre feet per acre during the irrigation season of each year.

Measurement, recording and reporting conditions:

- A. The water user shall maintain the totalizing flow meters or other suitable measuring device(s) in good working order. The totalizing flow meters must be maintained as identified in OAR 690-507-645. The water user shall keep a complete record of the amount of water used each month, and shall submit a report which includes the recorded water use measurements to the Department at its request. Further, the Director may require the water user to report general water use information, including the place and nature of use of water under the right.

To the extent that water is naturally available, it is the water user's responsibility to allow 0.5 CFS to pass the authorized point of diversion for this right on Big Creek. In the event that less than 0.5 CFS is naturally available, **ALL natural flow will be** allowed to pass the diversion point. Measurement is required through weirs or other suitable measuring devices upstream and downstream from the diversion point.

Diversion and use of water under this right must comply with the Clean Water Act and utilize the best management practices as identified in the plan developed as specified in the New River Alternation Dispute Resolution Team Agreement of file with the Department.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

This superseding certificate is being issued to correct scrivener's errors contained in Certificate 88471.
