CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SCHULZ REVOCABLE JOINT FAMILY TRUST LEO & JANICE SCHULZ, TRS 1512 NW OCEANVIEW DRIVE NEWPORT OR 97365

confirms the right to use the waters of LITTLE RIVER, tributary to NORTH UMPQUA RIVER for IRRIGATION of 1.0 ACRE.

This right was perfected under Permit S-38576. The date of priority is MAY 6, 1975. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.011 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point(s) of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original point of diversion described as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered January 8, 1999, at Special Order Volume 53, Page 9, approving Transfer Application 7357, and together with Certificate 75957, supercedes Certificate 45923, State record of Water Right Certificates.

The use shall be limited when it interferes with any prior surface or ground water rights.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
