## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL 2, WITH IN THE ZOLLNER CREEK BASIN for IRRIGATION of 18.88 ACRES.

This right was perfected under Permit G-10930. The date of priority is APRIL 13, 1988. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 106.0 GALLONS PER MINUTE or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water used.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include air lines and pressure gauges or access ports for a measuring line, adequate to determine water level elevation in the wells at all times.

Water shall be acquired from the same gravel aquifer as the original point of appropriation

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF APPROPRIATION, approved by an order of the Water Resources Director entered JUNE 8, 1999, at Special Order Volume 53, Page 837, approving Transfer Application 8048, and supercedes Certificate 75817, State record of Water Right Certificates.
