CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of ALBERTSEN WELL #2 and A WELL, within the SILVER CREEK BASIN for **IRRIGATION of 30.7 ACRES.**

This right was perfected under Permit U-665. The date of priority is AUGUST 23, 1954. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.38 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Measurement, recording and reporting conditions:

- A. The water user shall maintain the meter or other suitable measuring device in good working order
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new point of appropriation (well), together with that diverted at the old point of appropriation, shall not exceed the quantity of water available from the original point of appropriation.

Water shall be acquired from the same aquifer as the original point of appropriation.

This certificate is issued to confirm AN ADDITIONAL POINT OF APPROPRIATION AND CHANGE IN PLACE OF USE approved by an order of the Water Resources Director entered SEPTEMBER 23, 2009, at Special Order Volume 78, Page 943, approving Transfer Application 10709, and together with Certificate 85707, supercedes Certificate 28571, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
