confirms the right to use the waters of SPRING BRANCH, a tributary of the WALLA WALLA RIVER, for IRRIGATION on 10.6 acres and SUPPLEMENTAL IRRIGATION on 18.06 ACRES.

This right was perfected under Permit S-19303. The date of priority is MARCH 14, 1950. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.68 CUBIC FOOT PER SECOND (cfs) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
