CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL, within the PATAWA CREEK BASIN for IRRIGATION of 8.68 ACRES.

This right to be modified, as evidenced by a PORTION o Certificate 53555, was perfected under Permit G-9321. The date of priority is FEBRUARY 11, 1980. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.092 CUBIC FEET PER SECOND, if available at the original well or its equivalent in case of rotation, measured at the well.

The well is located as follows:

2 N	33 E	WM	29	NW NE	630 FEET SOUTH & 1480 FEET WEST FROM NE CORNER, SECTION 29

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point of appropriation (well), together with that diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.

2 N	33 E	WM	29	NW NE	7205 FEET SOUTH & 10 FEET EAST FROM N ¼ CORNER, SECTION 29

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water used.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in the portion of the right approved by an order of the Water Resources Director entered December 28, 2001, at Special Order Volume 55, Page 1389, approving Transfer Application 8814, and together with Certificate 79088 and Certificates confirming Transfer Applications 8583 and 8669, supersedes Certificate 53555, State record of Water Right Certificates.
