CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PATRICK AND JANE HENRY
407 HAMILTON RD
JACKSONVILLE OR 97530

confirms the right to use the waters of LITTLE APPELEGATE RIVER, tributary to APPELEGATE RIVER for IRRIGATION OF 3.0 ACRES AND STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is SEPTEMBER 1, 1857.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.06 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

A description of the place of use is as follows:

The quantity of water diverted at the new point(s) of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original point of diversion described as follows:

Note: This certificate conforms to the provisions of a decree of the Circuit Court for Jackson County dated April 19, 1928, in conformity with Mandate of Supreme Court.

The water user shall maintain and operate an in-line flow meter, weir, or other suitable measuring device as required by the Department.

The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a CHANGE IN POINT OF DIVERION approved by an order of the Water Resources Director entered JUNE 29, 2009, at Special Order Volume 78, Page 271, approving Transfer Application 8949, and together with Certificate 85654, supercedes Certificate 81415, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.
