## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SOUTH FORK WALLA WALLA RIVER, tributary to WALLA WALLA RIVER, tributary to COLUMBIA RIVER for DOMESTIC, LIVESTOCK, AND IRRIGATION OF 1.08 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at Page 9. The date of priority is 1891.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed one and one-half miner's inches per acre measured at the point of diversion.

The point of diversion is located as follows:

## NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall maintain a fish screen or fish by-pass device.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered October 23, 2006, at Special Order Volume 70, Page 367, approving Transfer Application 8587, and together with Certificates confirming Transfer Application 10219 and Transfer Application 10220, supersedes Certificate 81641, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
