 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of LITTLE BEAVER CREEK, tributary to GALES CREEK for DUST CONTROL.

This right was perfected under Permit S-26029. The date of priority is MARCH 5, 1959. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.006 CUBIC FOOT PER SECOND, NOT TO EXCEED A TOTAL VOLUME OF 1.25 ACRE FEET DURING THE IRRIGATION SEASON OF EACH YEAR, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
2 N	5 W	WM	25	SE NE	600 FEET NORTH AND 120 FEET WEST FROM E1/4 CORNER, SECTION 25

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original point of diversion described as follows:

2 N	5 W	WM	25	SE NE	1200 FEET NORTH AND 151 FEET WEST FROM E1/4 CORNER, SECTION 25

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall maintain a fish screen or fish by-pass device, as appropriate, at the point of diversion.

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in CHARACTER OF USE, PLACE OF USE, AND POINT OF DIVERSION approved by an order of the Water Resources Director entered November 29, 2004, at Special Order Volume 62, Page 288, approving Transfer Application 9547, and together with Certificate 81016, supersedes Certificate 29793, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
