confirms the right to use the waters of WELL #2 AND WELL #3, within the UMATILLA RIVER BASIN for IRRIGATION of 7.0 ACRES.

This right was perfected under Permit G-11281. The date of priority is APRIL 25, 1991. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.103 cubic foot per second, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation and shall be limited to the basalt aquifer below the depth of the alluvial gravels.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
