## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OREGON DEPARTMENT OF FISH AND WILDLIFE 3406 CHERRY AVE NE SALEM OR 97303

confirms the right to use the waters of TYGH CREEK AND JORDAN CREEK, tributaries to WHITE RIVER for IRRIGATION of 11.7 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wasco County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7, at Page 196. The date of priority is 1884.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed THREE ACRE FEET PER ACRE DURING ANY IRRIGATION SEASON (WITH THE FURTHER LIMITATIONS CONTAINED IN PARAGRAPH 24 OF SAID DECREE), or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion (POD) are located as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall maintain a fish screen or fish by-pass device, as appropriate, at the point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in POINT OF DIVERSION AND ADDITIONAL POINTS OF DIVERSION approved by an order of the Water Resources Director entered JANUARY 10, 2007, at Special Order Volume 71, Page 26, approving Transfer Application 7185, and supersedes a portion of Certificate 5755, State Record of Water Right Certificates.
