confirms the right to use the waters of ROCK CREEK, tributary to SOUTH YAMHILL RIVER for MUNICIPAL USE.

This right was perfected under Permit S-35398. The date of priority is JULY 24, 1970. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.05 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The quantity of water diverted at the new point of diversion may occur year-round at a total rate not to exceed 0.06 cubic foot per second on a non-continuous basis and shall be further limited to a total volume of water not to exceed 17.49 acre-feet per year.

The point of diversion is located as follows:

The water user shall maintain a fish screen or fish by-pass device, as appropriate, at the point of diversion.

This certificate is issued to confirm changes in character of use, place of use and point of diversion approved by an order of the Water Resources Director entered January 29, 2008, at Special Order Volume 74, Page 87, approving Transfer Application 9581, and supersedes Certificate 47319, State record of Water Right Certificates.

This certificate is being issued to correct a scrivener's error in the conditions for this right. ODFW notified the Department that the fish screening and by-pass were not required for this right. The condition was inadvertently included in the certificate. This certificate supersedes certificate 88014.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
