CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KRAEMER FARMS
13318 DOMINIC RD NE
MOUNT ANGEL OR 97362

confirms the right to use the waters of TWO WELLS, within the BUTTE CREEK BASIN, for SUPPLEMENTAL IRRIGATION of 6.8 ACRES.

This right was perfected under Permit G-10144. The date of priority is SEPTEMBER 20, 1983. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.043 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

6 S	1 E	WM	17	NW NW	1200 FEET SOUTH AND 80 FEET EAST FROM NW CORNER, SECTION 17
6 S	1 E	WM	17	SE NW	1470 FEET SOUTH AND 1990 FEET EAST FROM NW CORNER, SECTION 17

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

6 S	1 E	WM	9	NW SW	6.8

The water user shall maintain an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of ground water discharged into Butte Creek.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This certificate is issued to confirm a CHANGE IN PLACE OF USE approved by an order of the Water Resources Director entered JULY 15, 1999, at Special Order Volume 53, Page 1072, approving Transfer Application 8169, and together with Certificate 83085, supercedes Certificate 65144, State record of Water Right Certificates.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
