confirms the right to use the waters of A WELL, within the DESCHUTES RIVER BASIN for IRRIGATION of 5.34 ACRES.

This right was perfected under Permit G-10624. The date of priority is JANUARY 16, 1985. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.07 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The Director may require the water user to install a totalizing a flow meter or other suitable measuring devices at each point of appropriation. If the Director notifies the water user to install a totalizing flow meters or other measuring devices, the water user shall install such devices specified by the Director within the period allowed in the notice. Once installed, the water user shall maintain the meters or measuring devices in good working order and shall allow the Watermaster access to the meters or measuring devices.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered OCTOBER 2, 2009, at Special Order Volume 79, Page 4, approving Transfer Application 10449, supercedes Certificate 82717, State record of Water Right Certificates.
