This right was perfected under Permit G-6174. The date of priority is JULY 2, 1974. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.30 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
