## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL, within the SAND HOLLOW for IRRIGATION of 18.0 ACRES.

This right was perfected under Permit G-8903. The date of priority is NOVEMBER 7, 1979.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.23 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a CHANGE IN PLACE OF USE approved by an order of the Water Resources Director entered AUGUST 4, 2003, at Special Order Volume 57, Page 1248, approving Transfer Application 7883, and together with Certificate 80388, supercedes Certificate 52398, State record of Water Right Certificates.
