CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BERNARD E DAMON AND JEAN M DAMON
TRUSTEES OF THE DAMON JOINT TRUST

EUGENE OR 97401

confirms the right to use the waters of A WELL, within the WILLOW CREEK BASIN for IRRIGATION OF 7.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 11.6 ACRES.

This right was perfected under Permit G-1677. The date of priority is AUGUST 22, 1960.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.22 CUBIC FOOT PER SECOND (CFS), BEING NO MORE THAN 0.09 CFS FOR IRRIGATION OF 7.0 ACRES AND 0.15 CFS FOR SUPPLEMENTAL IRRIGATION OF 11.6 ACRES, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new point of appropriation (well) shall not exceed the quantity of water available from the original point of appropriation described as follows:

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water used.

Water shall be acquired from the same aquifer as the original point of appropriation.

This certificate is issued to confirm a CHANGE IN POINT OF APPROPRIATION approved by an order of the Water Resources Director entered NOVEMBER 19, 1998, at Special Order Volume 52, Page 1026, approving Transfer Application 8069, and supercedes Certificate 34277, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
