CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CYRUS POWELL
MILTON-FREEWATER, OREGON 97862

confirms the right to use the waters of LITTLE WALLA WALLA RIVER, a tributary of COLUMBIA RIVER for TRACT 2, for IRRIGATION of 1.0 ACRE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at Page 9. The date of priority is 1871. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE AND ONE-HALF MINER'S INCHES (0.0375 cubic foot per second) PER ACRE, measured at the point of diversion.

A description of the place of use to which this right is appurtenant is as follows:

being within the following described tract: Commencing at a point 6 rods 6.5 feet North of the southwest corner of the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Sec. 35, T. 6 N., R. 35 E., W. M., running thence east 80 rods to the Section line; thence north 6 rods 10 feet; thence west 35 and 1/5 rods; thence north 37 rods; thence west 44 and 4/5 rods; thence south 43 rods more or less to the point of beginning; EXCEPTING the following described land sold to Harry Graham, to-wit:

Beginning at a point 6 rods 6.5 feet north of the southwest corner of the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Sec. 35, T. 6 N., R. 35 E., W. M., running thence east 80 rods to said Section line; thence north 6 rods 10 feet; thence west 35 and 1/5 rods; thence north 25 rods 3 feet; thence west 44 and 4/5 rods; thence south 31 rods 13 feet to place of beginning.

ALSO: Commencing at a point 41 rods 11 feet north of the southeast corner of the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Sec. 35, T. 6 N., R. 35 E., W. M., running thence west 19 rods 3.5 feet; thence north 8 rods 5.5 feet; thence east 19 rods 3.5 feet; thence south 8 rods 5.5 feet to point of beginning, containing 1 acre.

This certificate describes that portion of the water right confirmed by Certificate 76328, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered AUG 16 2013, approving Notice T-11611.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
