confirms the right to use the waters of WALLA WALLA RIVER, a tributary of COLUMBIA RIVER for TRACT 1, for IRRIGATION of 11.28 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at Page 9. The date of priority is 1876. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE AND ONE-HALF MINER'S INCHES (0.0375 cubic foot per second) PER ACRE, measured at the point of diversion.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

being within the following described tract: Commencing at a point on the line running east and west through the center of the S $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Section 18, T. 5 N., R. 36 E., W.M., said point being 38 rods east of the west line of said Section; running thence east of south 21 rods to a point 19 rods distant at right angles from said east and west center line; thence west parallel with the center line 35 rods more or less to the center of the channel of the Walla Walla River; thence southeasterly up the center of the channel of the Walla Walla River to the line running east and west through the center of said Sec. 18; thence east along the center line of said section, 77 rods more or less to the County road; thence northwesterly along said County road to the line running east and west through the center of the S $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Sec. 18; thence west along said center line 41 rods more or less to the place of beginning.

This certificate is issued to confirm a change in POINT OF DIVERSION due to Government Action (ORS 540.510(6)), approved by an order of the Water Resources Director entered AUG 16 2013, regarding Notice T-11611, supersedes Certificate 76328, State Record of Water Right Certificates.

Said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of water for irrigation purposes is restricted to the lands or place or use herein described.
