confirms the right to use the waters of WALLA WALLA RIVER, a tributary of COLUMBIA RIVER for IRRIGATION of 3.66 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at Page 9. The date of priority is 1873. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE AND ONE-HALF MINER'S INCHES (0.0375 cubic foot per second) PER ACRE, measured at the point of diversion.

The point of diversion is located as follows:


being within the following described tract: Beginning at the northwest corner of the S $\frac{1}{2}$ of the S $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Sec. 18, T. 5 N., R. 36 E., W. M., running thence East 38 rods; thence southeasterly 21 rods; thence west 45 rods and 12 feet to the west line of Sec. 18; thence north 19 rods to the place of beginning, containing 5 acres, more or less.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in POINT OF DIVERSION due to Government Action (ORS 540.510(6)), approved by an order of the Water Resources Director entered AUG 16 2013, regarding Notice T-11611, and together with Certificate 88767, supersedes Certificate 12769, State Record of Water Right Certificates.

Said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of water for irrigation purposes is restricted to the lands or place or use herein described.
