confirms the right to use the waters of WALLA WALLA RIVER, a tributary of COLUMBIA RIVER for IRRIGATION of 5.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at Page 9. The date of priority is 1873. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE AND ONE-HALF MINER'S INCHES (0.0375 cubic foot per second) PER ACRE, measured at the point of diversion.

The point of diversion is located as follows:

This certificate is issued to confirm a change in POINT OF DIVERSION due to Government Action (ORS 540.510(6)), approved by an order of the Water Resources Director entered August 16, 2013, regarding Notice T-11611, and supersedes Certificate 13219, State Record of Water Right Certificates.

Said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of water for irrigation purposes is restricted to the lands or place or use herein described.
