CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GRAND ISLAND LLC
2603 E BEAVER LAKE DR SE
SAMMAMISH WA 98075

confirms the right to use the waters of LAMBERT SLOUGH, tributary to WILLAMETTE RIVER for IRRIGATION of 15.0 ACRES.

This right was perfected under Permit 40706. The date of priority is FEBRUARY 27, 1976. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.19 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion (POD) are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.


NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered MAY 6, 1999, at Special Order Volume 53 Page 676 approving Transfer Application 6794, and together with Certificate 76156, supercedes Certificate 57497, State record of Water Right Certificates.

This certificate is issued to correct an error in the location of the place of on certificate 88150, and supercedes certificate 88150.
