CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of CUMMINGS CREEK, tributary to JOHN DAY RIVER for SUPPLEMENTAL IRRIGATION of 24.1 ACRES.

This right was perfected under permit S-4497. The date of priority is MARCH 12, 1920. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.30 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing on the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable measuring device for measuring and recording the quantity of water diverted at the additional point of diversion. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall maintain a weir or other suitable measuring device for measuring and recording the quantity of water from Cummings Creek into the John Day River.

The water user shall maintain and operate a fish screen or by-pass device as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the diversion.

This certificate is issued to confirm a change of an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered February 27, 2006, at Special Order Volume 68, Page 113, approving Transfer ApplicationT-9590, and together with Certificate 81894, supersedes Certificate 80792, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
