CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SHIRLEY M. STONE
5500 LOST CREEK RD
EAGLE POINT OR 97524

confirms the right to use the waters of LOST CREEK AND WATER STORED IN LOST LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-427, tributaries of SOUTH FORK LITTLE BUTTE CREEK, for IRRIGATION OF 1.1 ACRES.

This right was perfected under Permit 3733. The date of priority is FEBRUARY 16, 1918. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.013 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
37 S	2 E	WM	3	NW SW	620 FEET SOUTH & 300 FEET EAST FROM W1/4 CORNER, SECTION 3

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

Twp	Rng	Mer	Sec	Q-Q	Acres
37 S	2 E	WM	3	NW SW	1.1

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water available from the original point of diversion.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface source as the original point of diversion.

The water user shall maintain a fish screen or fish by-pass device.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.


NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in POINT OF DIVERSION, CHARACTER OF USE approved by an order of the Water Resources Director entered AUGUST 6, 2003, at Special Order Volume 57, Page 1259, approving Transfer Application 8211, and together with Certificate 80391, supersedes Certificate 5783, State record of Water Right Certificates.
