The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a CHANGE IN CHARACTER OF USE approved by an order of the Water Resources Director entered OCTOBER 13, 2006, at Special Order Volume 70, Page 333, approving Transfer Application 10046, and supercedes Certificate 34395, State record of Water Right Certificates.
