## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SPRINGFIELD COUNTRY CLUB 90333 SUNDERMAN RD SPRINGFIELD OR 97478

confirms the right to use the waters of MOHAWK RIVER, tributary to MCKENZIE RIVER for IRRIGATION of 36.4 ACRES.

This right was perfected under Permit S-47707. The date of priority is SEPTEMBER 1, 1983. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.455 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5acre-feet per acre for each acre irrigated during the irrigation season of each year.

Measurement, recording and reporting conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring device in good working order.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This certificate is issued to confirm a CHANGE IN PLACE OF USE approved by an order of the Water Resources Director entered MARCH 16, 2011, at Special Order Volume 83, Page 814, approving Transfer Application 10981, and supercedes Certificate 82065, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
