## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LITTLE BUTTE IRRIGATION CO PO BOX 242 EAGLE POINT OR 97524

confirms the right to use the waters of LITTLE BUTTE CREEK, tributary to ROGUE RIVER for IRRIGATION of 30.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 14, at Page 498. The date of priority is 1883.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.58 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point where the water leaves the natural stream, from APRIL 1 TO OCTOBER 1 OF EACH YEAR.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface source as the original point of diversion.

This certificate is issued to confirm a change in POINT OF DIVERSION and PLACE OF USE approved by an order of the Water Resources Director entered December 22, 1997, at Special Order Volume 51, Page 1390, approving Transfer Application 7664, and together with Certificate 75431, supercedes Certificate 72152, State record of Water Right Certificates.
