confirms the right to use the waters of LITTLE BUTTE CREEK, tributary to ROGUE RIVER for IRRIGATION of 13.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 14, at Page 498. The date of priority is 1908.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.323 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source, FROM APRIL 1 THROUGH OCTOBER 1 OF EACH YEAR.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface source as the original point of diversion.

The water user shall maintain a fish screen or fish by-pass device, as appropriate, at the point of diversion.

This certificate is issued to confirm a change in Point of Diversion and Place of Use approved by an order of the Water Resources Director entered December 22, 1997, at Special Order Volume 51, Page 1387, approving Transfer Application 7663, and together with Certificate 75430, supercedes Certificate 46674, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
