CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TROUT CREEK, a tributary to the DESCHUTES RIVER for IRRIGATION of 125.8 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jefferson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5, at Page 57. The date of priority is 1885 for Tract 1; 1906 for Tract 2; 1878 for Tract 3; 1897 for Tract 4; and 1908 for Tract 5.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.5 ACRE FEET PER ACRE DURING ANY PERIOD OF 30 DAYS OR 6.0 ACRE FEET PER ACRE DURING ANY IRRIGATION SEASON AND SHALL BE SUBJECT TO ALL OTHER CONDITIONS AND LIMITATIONS CONTAINED IN SAID DECREE.
