CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in UMATILLA RIVER BASIN for IRRIGATION of 2.6 ACRES.

This right was perfected under Permit G-7357. The date of priority is JUNE 2, 1997. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.0325 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
5 N	29 E	WM	31	NW SW	680 FEET SOUTH AND 740 FEET EAST FROM W1/4 CORNER, SECTION 31

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new points of appropriation (wells), shall not exceed the quantity of water available from the original point of appropriation described as follows:

5 N	29 E	WM	31	S ½ NW SW	1500 FEET NORTH AND 200 FEET EAST FROM SW CORNER, SECTION 31

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
