CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL, in the MALHEUR LAKE BASIN for IRRIGATION of 126.7 ACRES.

This right was perfected under permit G-8527. The date of priority is MARCH 29, 1979. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.85 CUBIC FOOT PER SECOND measured at the points of appropriation.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right to the use of water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department the water user shall install, maintain and operate an in-line flow meter or other suitable device for measuring and recording the quantity of water diverted. The type of measuring device must be approved and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described.

This certificate is issued to confirm a change in POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered September 27, 2007, at Special Order Volume 73, Page 334, approving Transfer Application 10321, and together with Certificate 83402, supersedes Certificate 82697, State Record of Water Right Certificates.
