confirms the right to use the waters of A WELL, within the SPRAGUE RIVER BASIN for IRRIGATION of 50.67 ACRES.

This right was perfected under Permit G-10079. The date of priority is JUNE 16, 1982. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.63 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The right herein granted shall be subject to prior rights to appropriate groundwater from the ground water reservoir which serves as the source of the appropriation authorized herein.

Should it be determined subsequent to the issuance of this certificate that the appropriation of ground water herein authorized has a measurable effect on the flow of WHISKEY CREEK AND/OR ITS TRIBUTARIES, the appropriation of ground water herein authorized shall be regulated in accord with prior rights to appropriate such surface water flow.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
